Date: 6/15/17

Chair also noted Odyssey is the only 2 time winner of the Pat Flanagan Award. Chair asked everyone to introduce themselves and who they represented and asked everyone to ensure they signed in. Roll call to establish a quorum: Gerry Schoonmaker, Present; Patrick Murphy, Present; Steve Saffels, Present; John Wolfe, Present. Quorum established. Murphy took a picture of John Wolfe who was this year's winner of the Pat Flanagan award but was not able to be at the conference to receive it. The meal was served.
